#### **Executive Summary**

A request by TKG St. Peters Shopping Center, LLC (owner) to vacate easements located on the west side of Providence Road, across from Locust Street. (Case #14-42)

#### Discussion

The request is to vacate utility easements that were reserved over portions of rights-of-way for Second Street, Locust Street, and an unnamed alley from the Original Town of Columbia survey, all of which were vacated in 1966. New easements are being dedicated to cover existing sewer and water lines on the final minor plat of University Centre Subdivision, which is scheduled for a final Council decision on May 19, 2014.

City staff and external utility providers have reviewed the request and found it to be acceptable. Locator maps and a description of the easements to be vacated are attached.

#### **AN ORDINANCE**

vacating utility easements in portions of the Second Street, Locust Street and public alley rights-of-way; directing the City Clerk to have a copy of this ordinance recorded; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council finds and determines that certain reserved utility easements in portions of the formerly vacated Second Street, Locust Street and public alley rights-of-way, more particularly described as follows:

Utility Easement rights described in City Ordinance No. 2949, to Vacate, located in the Original Town, now City, of Columbia, Missouri:

- Second Street right-of-way, from Locust, south to the south line of Original Town
- 2. That portion of Locust Street right-of-way, located on the tract of land described by a deed recorded in Book 1426, Page 295.
- 3. The public alley right-of-way, located between Lots 7, 8, 9 and Lots 58, 59, 60.
- 4. The public alley right-of-way, located between Lots 5, 6 and Lots 61, 62, located on the tract of land described by a deed recorded in Book 1426, Page 295.

are in excess and surplus to the needs of the City and are hereby vacated.

SECTION 2. The City Clerk is hereby authorized and directed to cause a copy of this ordinance to be recorded in the office of the Recorder of Deeds of Boone County, Missouri.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.




