### Please be familiar with our rules

- ◆ All foot techniques to a legal target area awarded two points.
  - ◇ All hand techniques are awarded one point
  - ◇ Matches are five points or two minutes running time, in the case of a tie, the next point wins.
- ◆ Point areas are: chest, stomach, side of body and head gear area.
  - ◇ No face contact under adult brown belt
  - ◇ No groin contact
  - ◇ No ground fighting
- ◆ Minus points awarded for: face contact, accumulation of two warnings, accidental heavy contact.
- ◆ Disqualification for: malicious attacks, two minus points, unsportsmanlike conduct, disrespect to officials, excessive contact or causing swelling or bleeding of opponent.

**Important Notice:** Martial Arts is a contact sport with a degree of risk or injury. All participants must agree to assume that risk.
